

FACILITY POLICIES AND PROCEDURES

CONDUCT POLICY

Athletes, spectators, and guests are expected to set a superior example of sportsmanship and respect of others on the premises. Abusive or offensive language will not be tolerated. Physical violence of any kind will result in immediate removal from the venue. Spectators are not allowed on field of play. Individuals in violation of the conduct policy may be asked to leave.

FACILITY ABUSE

Any abuse of the facility or any activity that threatens the safety of other guests can be cause for expulsion from the complex either temporarily or permanently. Do not hang on goals or nets. (Could cause injury or death)

FIREARMS

Firearms and all other weapons of any kind are strictly prohibited.

HANDICAP FACILITIES

Handicap parking and facilities are available on site.

MERCHANDISE VENDORS

Must be approved by the SCHEELS Sports Complex.

OUTSIDE FOOD AND BEVERAGES

Coolers and outside food and beverages are prohibited. Food service options are available for sale at our concession stands.

PARKING

Ample parking is available at the venue. No overnight parking is permitted. Parking fees may be charged for some events. Parking is only allowed in marked spaces. No parking on grass. Parking is at the vehicle owner's risk. Facility is not responsible for damage or theft of the vehicle nor its contents.

PET POLICY

Pets are not permitted at SCHEELS Sports Complex. Service animals are allowed for persons with disabilities.

REFEREE ABUSE

Referee abuse is not tolerated at SCHEELS Sports Complex. Verbal or physical abuse of a referee will be grounds for discipline during and after the match. Physical abuse of a referee will be reported to the police and charges pursued. Unruly spectators may cause the respective coach to be disciplined by the referee. Any dismissed (Red Card) coach must immediately leave the field area to a location outside the fence line. Any coach or fan who receives a "Red Card" must obtain permission from SCHEELS Sports Complex before being allowed back onto the facility.

SKATEBOARDS, SKATES, BIKES, SCOOTERS

Are prohibited on the complex.

SOLICITATION

Only SCHEELS sponsors will be allowed to distribute or circulate commercial advertisements at the complex.

TEMPERATURE POLICY

SCHEELS organized outdoor events will follow OSSSA heat and temperature guidelines.

TENT POLICY

SCHEELS guests are permitted to use "pop up" tents in bleacher or sidewalk areas. Tents must be safely secured. Absolutely no staking permitted on turf surfaces.

TOBACCO AND VAPING

SCHEELS is strictly a non-smoking facility. No smoking or other use of tobacco products including pipes, cigars, cigarettes, or chewing tobacco is permitted in any part of the competition fields and courts. Vaping is not permitted.

TURF FIELDS

Turf Field: drinks are limited to water only. No sports drinks, no gum, no food, no seeds, no sharp objects, no tobacco. Molded Cleats or Athletic Shoes are to be worn on turf. Signage expressing such shall be maintained near the turf fields. Violation of the policy by players, team officials or associated spectators will result in a fine of \$150, payable by the associated team. Failure to pay turf field violation fines and or repeated violations may result in loss of use privileges as determined by SCHEELS Sports Complex.

WEATHER POLICY

In the event of lightning or other severe weather conditions, play will be stopped, and guests will be directed by officials and/or coaches to secure zones until it is safe to resume play.
